Peterson Photography does grant to the client the right to print, copy, edit, or distribute any images given to the client in any manner the client wishes, so long as it does not limit their use by Peterson Photography.

At the contract signing, Peterson Photography reserves the time and date agreed upon and agrees to take no other reservations for that date. Cancellation or postponement will, therefore, result in the forfeiture of all money paid to Peterson Photography. A substantive change in venue would also constitute a cancellation for this purpose.

Twenty-five percent \_\_\_\_\_ of the package fee \_\_\_\_\_ will be due at the signing of this contract. A second twenty-five percent will be due six months before the wedding. The third twenty-five percent will be due one week before the wedding if paid by check or one day before the event if paid in cash. The final twenty-five percent plus all taxes and any third party fees will be due at the delivery of any or all images.
